Evaluation Updates from the CWRC

Robert Frost in his poem "Stopping by the Woods on a Snowy Evening", wrote:

In March, the evaluation team presented a poster at the University of South Florida Conference on the "Factors related to short-term outcomes of family engagement meetings in child welfare: Returning home, preventing a move and restriction of the living environment." The purpose was to explore which child, family, and conference-level factors contribute to the immediate impact of family engagement conferences on child placement. Utilizing data from Pennsylvania's Title IV-E Waiver project, three regression models were run for the following child outcomes: returning home, preventing a move to an out-of-home paid (OOH) placement, and moving to a less restrictive placement. Results indicated that child age and legal status were consistently predictive for all three outcomes.

Results indicated that child age and legal status were consistently predictive for all three outcomes. Additionally, the size of an informal support network at the conference and prior level of placement restrictiveness were associated with some outcomes. The findings are that:

- Age and legal involvement with the courts (parents or juveniles) were the most consistent predictors for the three placement outcomes:
 - o Involving and collaborating with legal partners is critical in preparing for conferences and in the facilitation of the conference;
 - Age is a factor, at both the very young age and adolescent. When age and court orders
 prohibit return or staying in the home, then the family conference could focus how everyone
 will work to keep parent/child bonds and connections with extended family strong during this
 out-of-home process;
- Coordination Practices should emphasize helping parents identify, locate and prepare family and friend supports for the conference;
- The level of restriction in the child's pre-conference living environment is a predictor of the level of restriction after conferencing. Assessment of what rules and structures are needed to keep children safe early in the trajectory of child welfare involvement may be important.
