## Implementation Committee

An Implementation Committee meeting was held on August 27, 2013. Each county presented an update on their implementation efforts as well as each county's planned process for moving towards their Component 3 interventions. Parameters surrounding the selection of interventions, number of interventions, and the desire for shared interventions among all participating counties was discussed and several questions are being referred to the Executive Committee for discussion.

Templates are currently under development for the Component 3 IDIR and for the Semi-Annual Progress Report. These items are in their final draft and should be sent to the counties in the next two weeks.

### ACS Discussion

A phone meeting was held on September 6, 2013 with New York City ACS to discuss their implementation of EBPs. A summary of the major themes was distributed to the group and we look forward to having ACS join us in December as part of our Shared Learning Collaborative.


