Resources Available to Youth in Wayne County

► Wayne County Children and Youth Services (WCCYS)

- Can remain in foster care until the age of 21 if at least one of the following criteria is met:
- - Completing high school or a similar program such as GED;
 - Being enrolled in college, community college or trade school;
 - o Participating in a program that will help you get a job (i.e. OVR);
 - o Working at least 80 hours per month; or
 - You cannot do one of the activities listed above because of a medical or mental health condition.
- Can provide transportation to appointments
- Provide PA Access coverage (medical, dental, mental health and vision insurance)
- Can make referrals to Mental Health, Drug and Alcohol or any community resources needed
- Develop a Transition Plan to identify areas that need to be worked on for a successful transition out of care
- Work with your family and other supportive connections to assist you in any way needed
- Case work services at least once month (visits)
- Court hearing every 3-6 months

► Wayne County Independent Living Program (ILP)

- Must have been in foster care on or after your 16th birthday
- Independent Living Case Manager through George Junior Republic or WCCYS
 - Develop a youth driven Independent Living Plan (ILP) to identify goals to be achieved for a successful transition to independent living
 - Minimum of weekly visits
 - Can provide transportation to appointments, college campuses, job interviews,
 - o Assist in making referrals to community resources
 - o Assist in applying to Higher Education, grants, loans, scholarships, etc...
 - Assist in resume writing, job application, job seeking/interviewing, etc...
 - o Can receive stipends for goal completion (\$50)
 - Can receive a college stipend or transition stipend not to exceed \$2000 to assist with college books, supplies, household items, furniture, etc...
 - One-time opportunity to receive a Room and Board stipend/policy (rent/housing assistance)
 - This stipend/policy will help pay rent on a sliding scale
 - Will help pay security deposit and start-up costs for household needs
 - To be eligible for the above youth must:
 - Completing high school or a similar program such as GED;
 - Being enrolled in college, community college or trade school;
 - Participating in a program that will help you get a job (i.e. OVR);
 - Working at least 80 hours per month; or
 - You cannot do one of the activities listed above because of a medical or mental health condition.
 - Show the ability to pay for other costs and sustain rent after the assistance is over
 - Have a bank account
 - Be discharged from foster care after the age of 18 years old and have not yet reached the age of 21
 - Can attend monthly IL groups
 - These groups focus on youth identified relevant topics, life skills development, and community service

- Youth can get help to obtain driver's license
 - Can attend driving school paid for by WCCYS IL Program

*The above services are available whether or not you are currently in care receiving "regular" IL services or have exited care and are receiving IL "Aftercare" services.

Goal #2 - Jon to create a plan for success upon his discharge and what this plan will look like, to include housing, treatment, employment, transportation, and exploring health insurance options

♦ Living Arrangements/Housing

- Jon plans to live with his mother, Maria Smith
 - Until he chooses to go to college and live on campus if he decides
- Jon can also:
 - o Live with Grandma Elsie Jones
 - o Stay at his aunt Carmela White's home on the weekends
 - Stay at the dorm at college
- Family will get a bed and furniture for Jon
 - o Family will purchase Jon a bed and mattress for him
 - Family will get necessary furniture, desk, etc. for Jon and have his room set up before he is discharged
 - Family will shop for needs

♦ Employment

- Jon will work weekends part-time
- Jon can work on campus, restaurant, supermarket, retail, in an office
- Family will help Jon find employment and help him buy clothes/uniform he needs to be able to work

◊ Transportation

- Jon wants to get his driver's permit
 - o Carmela will help Jon with getting his permit and offer driving lessons
 - o Maria will help Jonathan learn the public transportation system

♦ College

- Jon has already filled out FAFSA form and submitted it
- Jon would like to attend college for Fall 2013
 - o If he is not accepted in Fall 2013 then he would like to attend Spring of 2014
- Jon has college applications completed but needs to submit them to be accepted into college
 - Jon will submit these application to his Senior Advisor at George Junior Republic
 - George Junior Republic will pay for any college application fees
- Jon will research with his therapist, Dave Brown, other colleges he is interested in that are located in New York
 - o He will research this by Tuesday, April 16, 2013
 - o He will submit the applications to his guidance counselor by April 26, 2013
 - Jon will follow up with is guidance counselor to make sure his application were sent off

◊ Treatment

- George Junior Republic will provide Jon with a 30 day prescription when he is discharged for his medication
 - They will also set up after care arrangements with a local provider for medication management for Jon
 - Maria will help Jon get his prescription filled and set up any needed appointments with Jon
 - Jon will willing to continue to appropriately manage his medication and take his meds
- Kimberly will check in with Jon regarding how he is managing his mental health needs

♦ Responsibilities

- Carmela and Elsie will help Jonathan set up a bank account, getting a credit card to establish credit and managing his finances
- Maria will help Jon get an appointment with the Department of Social Services to apply for government assistance/ Access for medical insurance
 - She will have the application all ready to fill out for when Jon is discharged
 - o This will be done within one week of him coming home
