### **Pennsylvania Child Protective Services Law: Module 4- Reporting and the Role of the Child Welfare Professional Transfer of Learning**

Participants who attend this classroom course must have completed *Pennsylvania Child Protective Services Law: Module 4 - Reporting and the Role of the Child Welfare Professional*. Critical thinking will be required to examine amendments to the CPSL and formulate a plan for offering support and guidance to community members. This workshop is eligible for up to **three** continuing education credit hours

### **Pennsylvania Child Protective Services Law: Module 6 - Disposition of Cases Transfer of Learning**

Participants who attend this classroom course must have completed *Pennsylvania Child Protective Services Law: Module 6: Disposition of Cases*. Critical thinking will be required to examine the amendments to the CPSL and apply decision making tools to case scenarios to determine the disposition of cases. This workshop is eligible for up to **four** continuing education credit hours.

These options are specifically designed for those who have completed Module 4 and Module 6. They provide specific learning activities related to those two courses.

### **Pennsylvania Child Protective Services Law: An Update for Child Welfare Professionals - Supervisor Support Session**

The Support Session and the Supervisor Support Session allow for facilitated discussion that can be adapted for use following the completion of any of the Pennsylvania Child Protective Services Law modules. Participants will have the opportunity to consider implementation effort, including that which is going well and areas of concern. Participants will also explore solutions to challenges and develop action plans for moving forward. Each course is targeted to either supervisors or caseworkers.
